Silver Birch (G2), reduce the height of the tree by up to 2.5m to prevent snap-out and reduce overall size x 1 Silver Birch (T1), reduce by 3 metres to leave finishing height of 5 metres to allow

the tree to reshoot from new pollard growth points x 2 Ash (G1), crown reduction by 3 metres and

shape to balance canopy and clear overhang of the road and footpath x 1 Purple Plum (T2), recommend the reduction in height by 2m from tips to prevent snap out and reduce overall size of

the tree in the position x 1 Silver Birch (T3) and remove as dead x 1 Hawthorn tree and x 1 Hawthorn bush (G1)
